S. P. B. English Medium College of Commerce is a leading commerce college of South Gujarat. It offers B.Com., M.Com., M.Phil and Ph.D. programmes. The College is a recognized centre for M.Phil (Commerce) since 2009-10. The College has highly learned faculties. Eight out of Twelve Faculties have Ph.D. Degree and rest are pursuing it. Eight teachers are recognized M.Phil guides and Six are recognized Ph.D. guides. On an average the faculty has more than Twenty Two years experience. Professional / subject expert teachers are invited at M.Com. programme.

#### **Objectives of the College**

The college was established in July-1991 with the following objectives which are also reflected in VISION and MISSION statement of the college:-

- (1) To keep education in the college truly "Sarvajanik" i.e. to keep it accessible and affordable to all the sections of the society without discrimination of religion, race, caste gender and socio-economics status etc.
- (2) To be a leading participant in the grooming of citizens who are respected for their knowledge, skills and competence and who can make significant contribution towards wholesome and inclusive progress and development of the society / nation.
- (3) To impart quality education and make the students competent for attainting a fulfilling career. i.e. to make them competent for becoming respectable professionals in Public, Private and Co-operative sectors.
- (4) To provide value based education so that the students can inculcate strong human values and develop commitment towards moral and social correctitude.
- (5) To instill in the minds of students a sense of responsibility and commitment towards secularism and humanitarianism.
- (6) To make all the SPBians (i.e. all the students and staff members of the SPB college family) life long learners for achieving maturity, progress and

prosperity for themselves, for the society and for the nation through continuous formal and informal studies and performances practices at every stage of the journey of life.

## Related information and rules and regulations for admission to this college

(1) The Teaching programme of the College is scheduled in two overlapping shifts. to accommodate the needs of advanced learners. However It may be noted by all concerned, that the college may change its timing and the shift arrangement as per the changing demands without any prior notice. At present the timings and the shift arrangement will be as follows:

All Classes of S.Y. and T. Y. B.Com (Including Self Financed) 7:30 onwards.

All Classes of F.Y.Com. (Including Self Financed) 11:00 onwards.

All Classes of M.Com. (Including Self Financed) 11:00 onwards.

- (2) The medium of instruction is English. Student's pursuing Graduation / Post Graduation through English Medium are accepted to have high level of competency in English (Reading, writing & speaking). We therefore strongly recommend students intending to migrate from vernacular (Gujarati / Hindi / Marathi) medium to English Medium to understand his/her level of preparedness to study through English medium before taking admission in college to ensure effective learning in higher education.
- (3) There are three divisions each for First Year, Second Year and Third Year Classes for grant-in-aid programme and one division each year for self finance programme.
- (4) A student seeking admission to this college has to apply for admission

- in the prescribed form and within the notified time.
- (5) It is obligatory for the F. Y. B.com students to join one of the activities viz. National Service Scheme (N.S.S.) or Physical Training (P.T.) or National Cadet Corps (NCC).
- (6) Seats are reserved for the candidates belonging to the categories like SC, ST, SEBC (Baxi Panch), PH and the children of Ex-Servicemen and students who have taken part / won prize in sports events at State / National level, as per Government and V. N. S. G. University rules, provided that they satisfy the University requirements and apply within the stipulated time. Students belonging to SEBC category must submit, along with application form, the necessary caste certificate and a certificate from a competent authority to the effect that they do not belong to the creamy layer group. Students applying for the sports quota should submit the copies of relevent documents in duplicate.
- (7) As per Veer Narmad South Gujarat University Ordinance No. 144, a student who has passed the examination of a Statutory University in India will not be allowed to appear at the same examination with the same subjects.
- (8) (a) Students who have studied and passed their Higher Secondary Examination held by Gujarat Secondary Education Board will be admitted to the college as per University rules on the basis of merit.
  - (b) Those students who have passed their Higher Secondary Examination from Boards other than Gujarat Secondary Education Board will be admitted as per the University rules.
  - (c) Students who have passed the Higher Secondary Certificate Examination held by a Board other than Gujarat Secondary

Education Board or those migrating from other Universities shall have to produce a Provisional Eligibility Certificate from the Veer Narmad South Gujarat University, after getting admission to this college. Such students will have to produce the Final Eligibility Certificate in due course. They will be admitted as per University rules on the basis of merit.

- (9) The College will follow the syllabus as prescribed by the Veer Narmad South Gujarat University, Surat.
- (10) (a) Students are expected to read the notices put up on the Notice Boards of the college and the college website from time to time. Ignorance of any notice or rules or regulation of the college / University will not be an excuse.
  - (b) Students are expected to observe all the rules and norms of discipline as laid down by the College.
- (11) ADMISSION GRANTED TO A STUDENT WILL BE CANCELLED IF THE INFORMATION PROVIDED BY HIM / HER IS EITHER FALSE OR IF HE / SHE WITHOLDS THE REQUIRED INFORMATION. IN SUCH CASES ALL THE FEES AND DEPOSITS WILL BE FORFEITED.
- (12) Admission to F. Y. B. Com. / M. Com. class will be given as per the merit list prepared, subject to the availability of seats by the centralised admission committee appointed by the university.

#### MOTTO OF NCC

The need for having motto for the Corps was discussed in the 11th Central Advisory Committee (CAC) meeting held on 11 Aug 1978. The mottos suggested were "Duty and Discipline" "Duty, Unity and Discipline," Duty and Unity", "Unity and Discipline." The final decision for selection of "Unity and Discipline" as motto for the NCC was taken in the 12th CAC meeting held on 12 Oct 1980.

#### **AIMS AND OBJECTIVES:**

The Aims of the NCC laid out in 1988 have stood the rest of time and continue to meet the requirements expected of it the current socio-economic scenario of the country. The NCC aims at developing character, comradeship, discipline, a secular outlook, the sprit of adventure and ideals of selfless service amongst young citizens. Further, it aims at creating a pool of organize, trained and motivated youth with leadership qualities in all walks of life, who will serve the National regardless of which career they choose. Needless to say, the NCC also provides an environment conducive to motivating young Indians to Join the armed forces.

#### **Evaluation Norms:**

As per the University rules,

- (1) It is compulsory for every student to appear at the Internal Tests.
- (2) Each and every student has to obtain atleast 36% marks in atleast half the number of subject heads in Internal Evaluation to be eligible to appear at the Final University Examination
- (3) Every student should attend the classes regularly. Students who do not fulfill the various requirements stipulated by the College / University

from time to time shall not be allowed to submit the assignments and / or to appear at the concerned Internal / University Examination and the Examination forms of such students shall be withdrawn by the Principal. The college's vision of "Study-Perform-Blossom" is based on expectation of each student's active involvement in college's accedemic-co-carricular-extra-carricular activities for all the years. Therefore college's management will have zero tolerance for parellel activities by students during the college timing.

(4) The proportion of University exam marks and internal evaluation is approximatery 70 % and 30% respectively.

The decision of the Principal regarding the withdrawals will be final.

#### FEES AND DEPOSITS:

- (1) All fees and deposits must be paid by cheque / transfer in college's account as per instruction from time to time at the college office counter. FEES ONCE PAID WILL NOT BE REFUNDED.
- (2) Admission form should be duly filled in and accompanied by all the necessary certificates. Those students who have been granted admission will be required to pay all the prescribed fees and deposits (from time to time) within the prescribed time-limit. The college office will remain open for this purpose from 7-30 a.m. to 3-00 p.m. on all working days. If the fees are not paid within the prescribed time limit, the admission granted will stand cancelled and the vacancy will be filled up by the next candidate according to the merit list.
